MANUFACTURED HOME NOTES

- Office publishes a downloadable Mobile Home Permit application and handles building permits, zoning, and code enforcement in one office.
- County also posts its Zoning Ordinance and Flood Prevention Ordinance on the Codes & Ordinances page of the county site.

Georgia: installation must follow the state Rules for Manufactured Homes (O.C.G.A. Title 8-2, Art. 2) using state-licensed installers; an installation permit and insignia are required, and local permits/inspections apply.

MOBILE HOME (Move-On) Permit Application

NOTE: Locating a mobile home on your property without having your PERMIT FIRST will result in your being fined/charged a double fee (\$600⁰⁰).

In order to move a mobile home into McIntosh County, you must provide the following:

- 1) **Septic Tank Permit/Inspection** (This must be obtained from Environmental Health, (912) 832-5473, even if there is an existing septic tank & well.)
- 2) **Plat** of the property where the mobile home will be located. *(Be sure the location is zoned to allow mobile homes.)*
- 3) If the property is in a flood zone, an Elevation Certificate will be required and will also need to be submitted with your application.
- 4) **Bill of Sale** or copy of **Sales Agreement** that shows Mobile Home ID# as well as the description and purchase price. Mobile homes must be at least 720 square feet – nothing smaller.

Also:

- a) You must have a state certified mobile home installer.
- b) A vapor barrier, #6 poly, **MUST** be placed underneath the mobile home.
- c) You **MUST** have a licensed electrician.

FEES:

\$100⁰⁰ Move-On Permit ***(This permit card must be in the truck when the mobile home is being moved)***
\$200⁰⁰ Inspection Fee
*\$100⁰⁰ Move-Off Permit (if the home is already in the county)

ALSO:

*Any mobile home being moved from one location to another within the county (providing it meets all requirements to do so) **MUST** obtain a Move-Off permit (\$100⁰⁰).

*Any mobile home being moved out of the county **MUST** obtain a Move-Off Permit (\$100⁰⁰).

(A copy of the current and paid-in-full Tax Receipt from the McIntosh County Tax Commissioner's Office must be presented with this packet before a Move-Off Permit will be issued.)

Mobile homes **MUST** have a vapor barrier underneath, **MUST** be tied down, **MUST** be hooked to both water and septic systems, **MUST** be under-skirted, and the electrical service **MUST** be ready for the power company to connect **BEFORE** the Inspector is called. Electrical wire must be in conduit.

***** MOBILE HOMES MUST HAVE THE CURRENT DECAL VISIBLE IN FRONT WINDOW**
BEFORE INSPECTION CAN BE DONE. ***

ABSOLUTELY NO POWER UNTIL THESE REQUIREMENTS ARE MET!!!

If an inspection fails, or if an inspection is called in and not ready when the inspector shows up on site, a Re-inspection Fee will be charged and must be paid before the inspector can re-visit the site:

2nd: \$50⁰⁰
