MANUFACTURED HOME NOTES

- Department issues manufactured home location permits in addition to building permits and business licenses.
- Same office handles code enforcement, zoning enforcement, rezoning, and subdivision regulation; county zoning is Appendix A of the code.
- Property inside Camilla city limits falls under City of Camilla Code Enforcement, (229) 330-2316.

Georgia: installation must follow the state Rules for Manufactured Homes (O.C.G.A. Title 8-2, Art. 2) using state-licensed installers; an installation permit and insignia are required, and local permits/inspections apply.

A Permit Will Not Be Issued Without This Information

A site inspection may be required prior to issuing a building permit

- [] 1 acre of land with 150 ft. of road frontage required per residence. Check the zoning district for the land. (1½ acre may be required by the Mitchell County Health Department - 336-2055) Burt Spence
- [] Septic Tank (perc test) & Well approval from Health Department (take a copy of your plat or a tax map from the Tax Assessors office to the Health Dept) Burt Spence
- [] Who is your manufactured home installer? (Must be State Licensed & Registered with the County)
- [] Who is your electrician? (Must be State Licensed & Registered with the County, electrician requests final inspection)
- [] Make an application for service with the electric company (EMC or Ga. Power)
- [] Take manufactured home contract or sales receipt & proof of paid taxes to the Tax Assessors Office (Courthouse - Room 101 - 336-2005)

*** No Mobile Home without (HUD Insignia) shall be brought into the County ***

*** Existing Mobile Homes in the County must be brought up to code **prior** to moving within the County***

***Effective Jan. 1st, 2005 A Licensed Manufactured Home Installer Is Required for Manufactured Homes ***
